

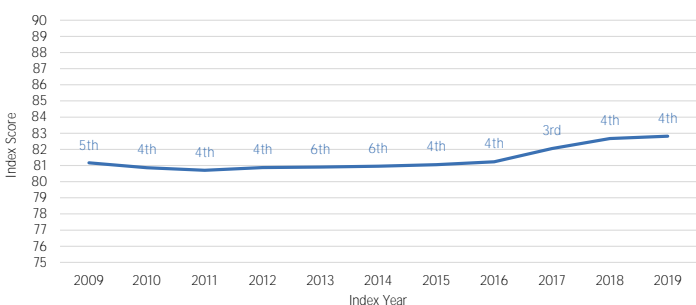

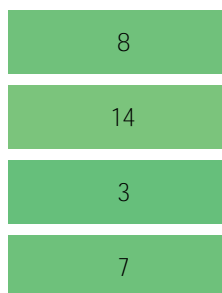
Economic Openness over time



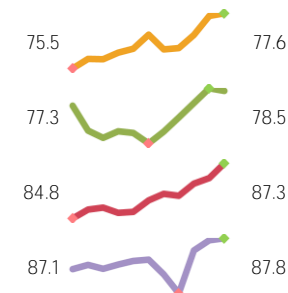
