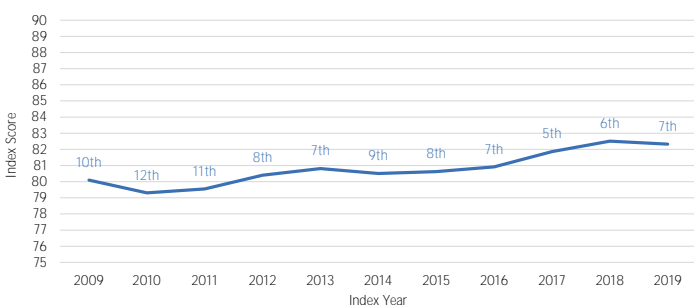

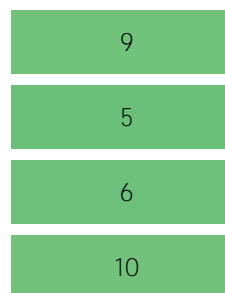
Economic Openness over time



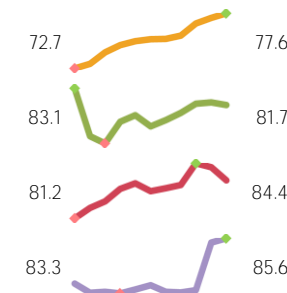
