

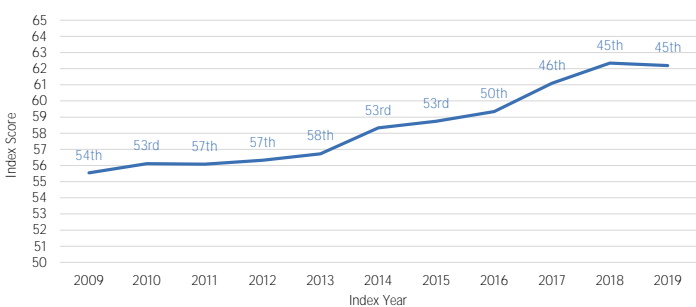

Economic Openness over time



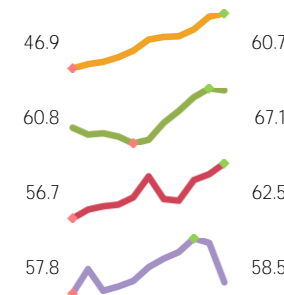
