

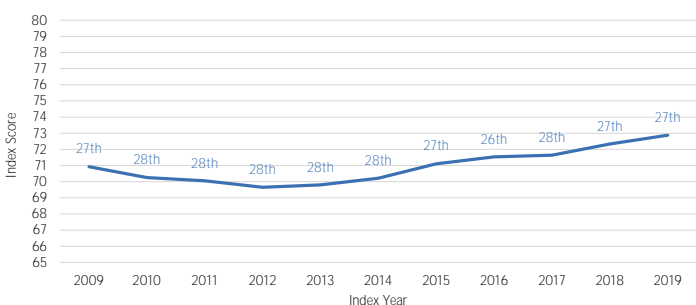

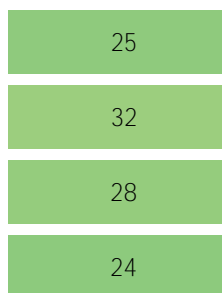
## Economic Openness over time



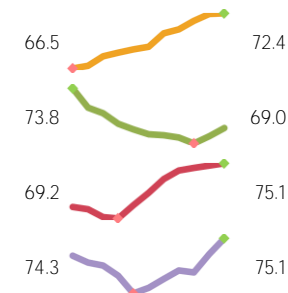
