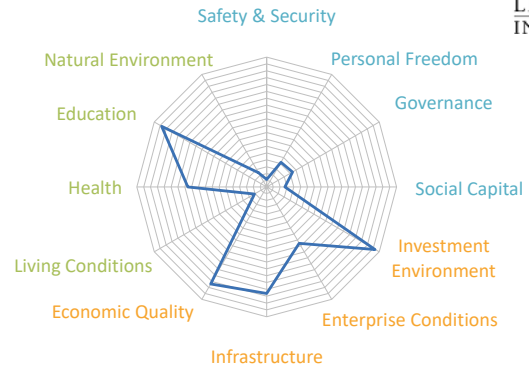
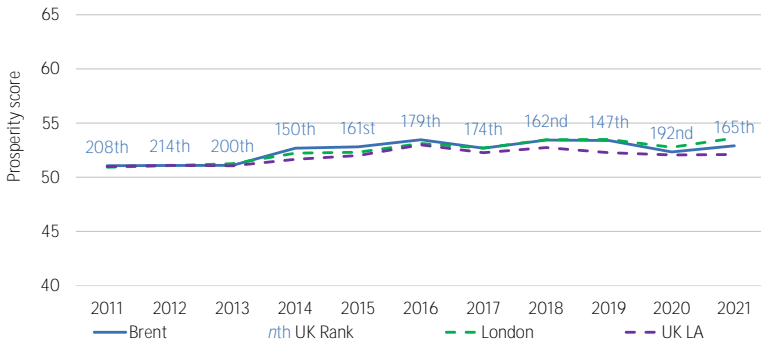


Brent: Prosperity score 52.9 (165th)
